(F)(5)). In addition, the Virginia Department of Social Service's Division of Licensing Programs has approved this course as a program in adult group activities and in recognizing and assessing the activity needs of residents.

You will also earn credit toward the National Certification Council for Activity Professionals Modular Education Program for Activity Professionals (NCCAP MEPAP) Part 1 certification requirements.
