# Danny TK Avula, MD, MPH | Commissioner Virginia Department of Social Services | Richmond, Virginia

Dr. Danny TK Avula was appointed as the commissioner of the Virginia Department of Social Services in February 2022 by Governor Youngkin. He is the former health director of the Richmond City and Henrico County Health Departments. From January 2021-January 2022, Governor Northam appointed Avula to lead the Commonwealth of Virginia's unprecedented COVID-19 vaccination effort.

Avula is a public health physician specializing in pediatrics and preventive medicine and continues to practice clinically as a pediatric hospitalist. After graduating from the University of Virginia, he earned his medical degree from the Virginia Commonwealth University School of Medicine. He completed residencies at VCU and Johns Hopkins University, where he also earned the master of public health degree. He is an affiliate faculty member at VCU, where he regularly serves as an advisor and preceptor to graduate and medical students.

Governor McAuliffe appointed Avula to the State Board of Social Services in 2013, and he served as board chair from 2017 to 2019. He is also a former board chair of the Richmond Memorial Health Foundation. He is a recent recipient of the Virginia Center for Inclusive Community's Humanitarian Award, a 2019 *Richmond Times-Dispatch* Person of the Year honoree and was named *Style Weekly*'s "Richmonder of the Year" in 2020. Avula's work has been featured nationally by the CDC, MSNBC, *The New York Times*, NPR, and PBS Newshour, and he can be found on the TED circuit with his TEDx talk entitled "Dependence Isn't a Dirty Word." At home in Richmond's Church Hill neighborhood, where he has lived for the past 16 years, Avula's time is devoted to life with his wife and five kids.

# Shirley Lefler Bazdar | Program Manager Claude Moore Charitable Foundation | Fairfax, Virginia

Shirley Bazdar has served public schools in the Commonwealth for more than 30 years. She has been a career and technical education teacher (marketing education), coach, high school administrator, and director of career and technical education in Northern Virginia. She spent 11 years working for the Manassas Park City Schools and 19 years working for the Loudoun County Public Schools.

After retiring from Loudoun County Public Schools in 2016, Bazdar became an educational consultant with the Claude Moore Charitable Foundation's Claude Moore Scholars program and continues to be an adjunct for Shenandoah University. Since July 2021, she has become the program manager for the Claude Moore Scholars program. The sole focus of her career has been to provide high school students with career pathways and opportunities that would prepare them to be college and career ready.

### Steve Ford | Senior Vice President for Policy and Reimbursement VHCA-VCAL | Richmond, Virginia

Steve Ford has an extensive background in Medicaid policy and regulation, strong research, and analytical skills, as well as significant relationships with policy makers and other health care organizations. In his current role, he leads VHCA-VCAL's initiatives related to Medicare/Medicaid payment issues and the transition to managed care.

Prior to joining VHCA-VCAL staff, Ford served in a variety of capacities at the Virginia Department of Medical Assistance Services (DMAS). From 2003 through 2014, his roles at DMAS included deputy director for administration, director of the policy and research division, and healthcare reimbursement manager. From 2000 to 2003 he served as the director of financial policy for the Virginia Hospital and Healthcare Association (VHHA). From 1994 to 2000 he served as principal legislative analyst for the Joint Legislative Audit and Review Commission (JLARC).

#### Laurie Forlano, DO MPH | Deputy Director, Office of Epidemiology Virginia Department of Health | Richmond, Virginia

Dr. Laurie Forlano serves as the deputy director of the Office of Epidemiology and deputy state epidemiologist. During the COVID-19 pandemic she was the inaugural co-leader of Governor Northam's COVID-19 Long Term Care Facility Task Force, and currently serves as the VDH COVID-19 operations section chief, overseeing teams related to testing, vaccination, containment, disease surveillance, and focused groups on long term care and K12 schools. Dr. Forlano has been with the Virginia Department of Health since 2011 in varied leadership positions in the Office of Epidemiology and Office of the Commissioner. She is a board-certified physician in preventive medicine and public health, a graduate of the Philadelphia College of Osteopathic Medicine and obtained her masters of public health at the University of Massachusetts.

# Melissa L. Green, RN, MSHA, RAC-C | Co-Founder and Chief Clinical Officer Trio Healthcare | Atlanta, Georgia

Melissa Green serves as chief clinical officer (CCO) of Trio Healthcare, LLC, a company she co-founded with two partners in 2016. In her capacity as CCO, Green provides leadership and guidance on all aspects of the clinical services provided at the company's 11 senior care facilities. She also serves as corporate compliance officer for the company.

Green has 20 years of experience in clinical leadership positions, with an emphasis on the senior healthcare industry. She has worked for multi-state providers within excess of 200 skilled nursing centers, as well as smaller regional companies. Green has had exceptional success in improving performance at clinically underperforming facilities, including facilities on provisional license and centers with open plans of correction. She implements systems that improve regulatory outcomes and clinical reimbursement processes.

Most recently, Green served as senior vice president of clinical operations for Reliant Senior Care until cofounding Trio Healthcare, LLC. From September 2011 to November 2015, she served as senior vice president of clinical operations and corporate compliance officer for AdCare Health Systems, which operated 38 SNFs and eight assisted living centers located in nine states. Green was appointed to the Virginia Board of Health in October 2021.

### David Gifford, MD, MPH | Sr. Vice President of Quality & Regulatory Affairs AHCA/NCAL | Washington, DC

Dr. David Gifford is the senior vice president of quality and regulatory affairs at AHCA/NCAL, the largest association in the country representing long term and post-acute care facilities. He helped create the department which assists providers in their quality improvement efforts and works with Administration officials on regulations and policies impacting the profession. Gifford also serves on the Board of the Advancing Excellence in America's Nursing Homes campaign and the Baldrige Foundation Board.
